

ARGENTINE RED SHRIMP (*Pleoticus muelleri*) COASTAL TRAWLING IN WATERS OF PROVINCE OF CHUBUT

RELEASE OF PUBLIC CERTIFICATION REPORT AND CERTIFICATION DECISION

Organización Internacional Agropecuaria (OIA) announces that Dispute Process for the Final Draft Report of the Argentine red shrimp coastal fishery is ended. No notice of objection was received during the consultation period. The Public Certification Report for this fishery is now available at the MSC website (<https://fisheries.msc.org/en/fisheries/argentine-red-shrimp-pleoticus-muelleri-coastal-trawling-fishery-in-waters-of-province-of-chubut/@assessments>).

The fishery achieved a score of 80 or more in all MSC Principles and did not score less than 60 in any performance indicator. Following the recommendation of assessment team and reviewing stakeholder and peer reviewer comments, OIA's decision making entity concluded that the fishery has passed the full-assessment process and determined its intention to certify with 7 conditions as sustainable against the MSC Fisheries Standard. The fishery is now certified for 5 years, subject to successful completion of annual surveillance audits. OIA determines that the date of certification is the date of the Public Certification Report is published on the MSC website.
